## **Correlation in Contests**

Resource allocation and decision making is often based on a contest where the interested parties expend effort to secure a desirable outcome. In contrast to markets and standard auctions, the cost is sunk rather than conditional on the outcome. In this talk, we discuss the effects of incomplete information on the equilibrium outcomes of contests with a special emphasis on the role of correlated information.
