We are pleased to announce that the 2024 NTU-AS International Symposium on Macroeconomics will be held at the Department of Economics, National Taiwan University on May 28, 2024.

We expect to bring together domestic and international researchers who conduct frontier work on the broader field of macroeconomics to create research ties, encourage research collaborations and exchange feedback on cutting-edge macroeconomic research. We plan to schedule seven papers, allocating 50 minutes to each, which gives us ample time for presentation and discussion.

The workshop will take place at the College of Social Sciences (Room 606) in the main campus of National Taiwan University which is located in the city center and a 10-minute walk from the nearest MRT station.
